to meet the needs of the populations it serves.

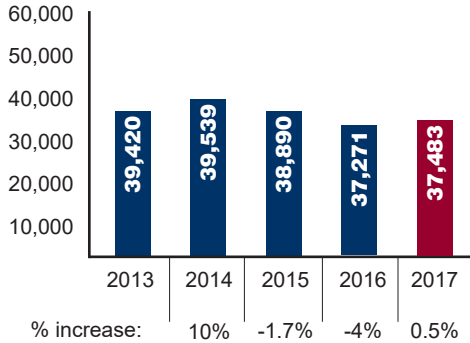
Community Health Professionals

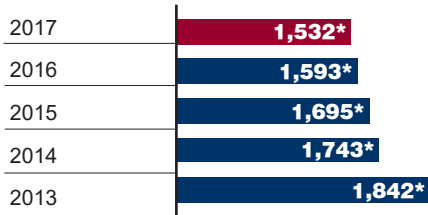
# HOME HEALTH CARE

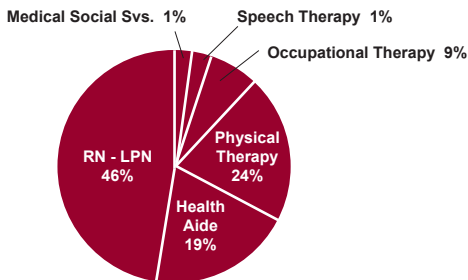


## Skilled Home Health Patients

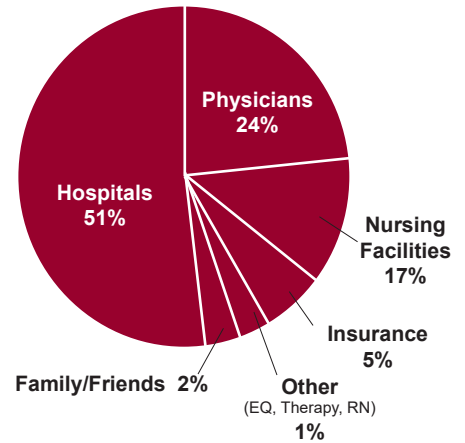

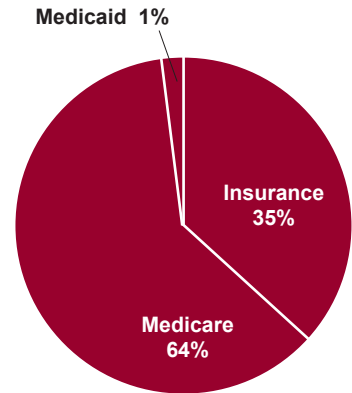
## Visits by Discipline



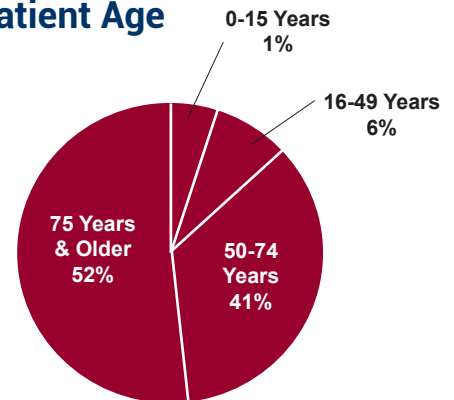
## Referral Sources



## Visits by Pay Source



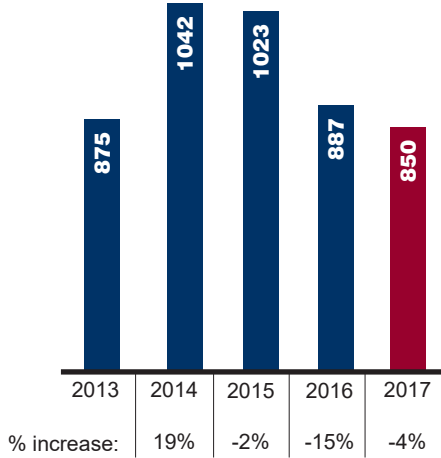
## Skilled Patient Age



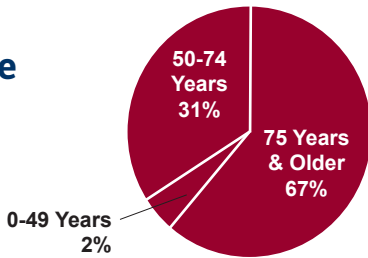
# HOSPICE

Community Health Professionals' Hospice provides care to individuals with terminal illness both in the home and in an inpatient setting.

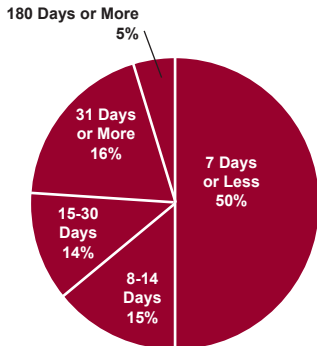
## Total Patients



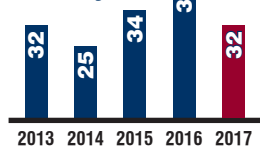
## Hospice Patient Age



## Length of Service



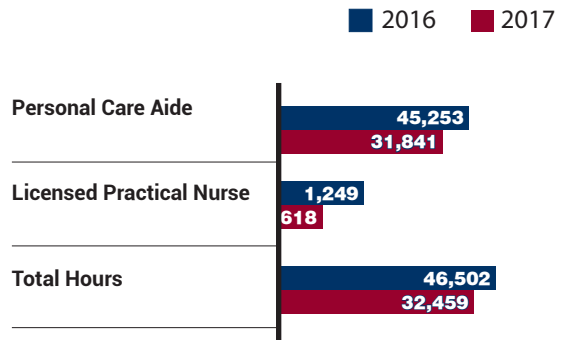

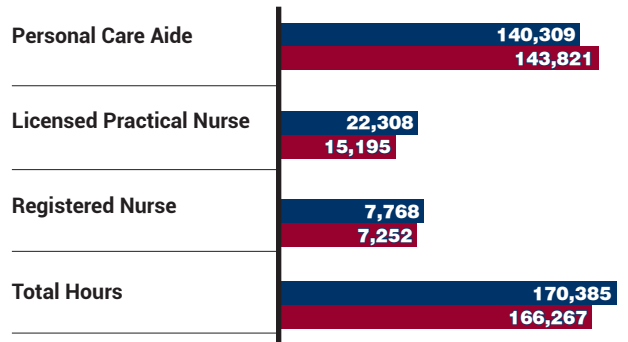
# PRIVATE DUTY SERVICES VNA COMPREHENSIVE SER.

## Private Duty - Hours Provided

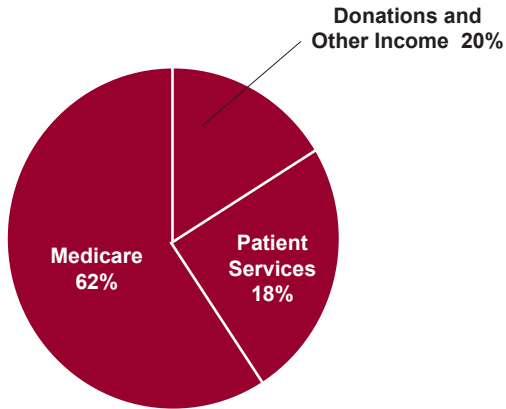


## VNA Comp. - Hours Provided



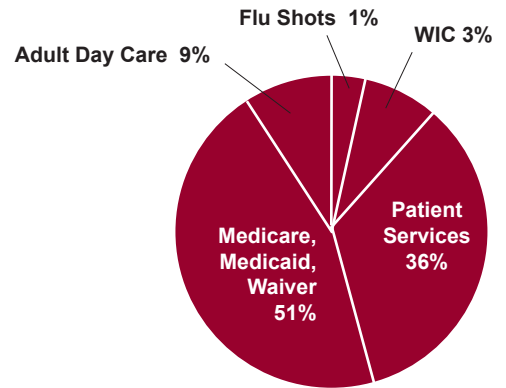

## Revenue Sources

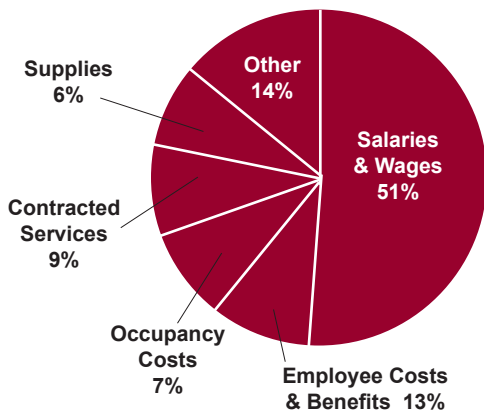
