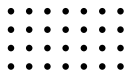

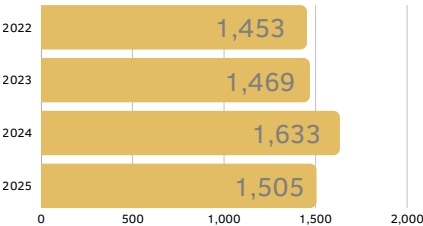

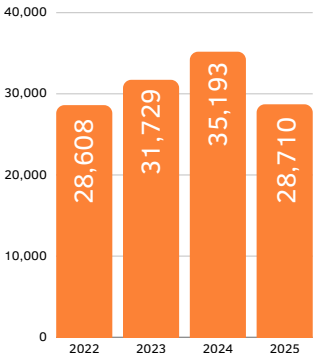

CHP Home Care & Hospice delivers in-home nursing care, physical, occupational, and speech therapy, home health aide, and medical social services.

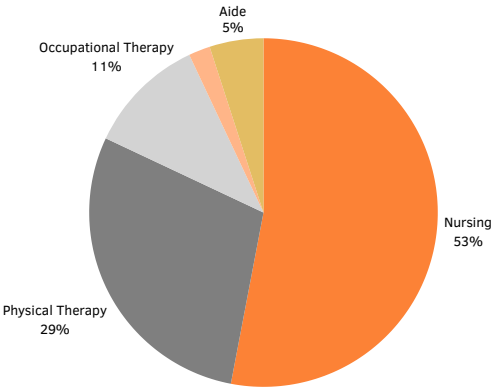

Total Visits

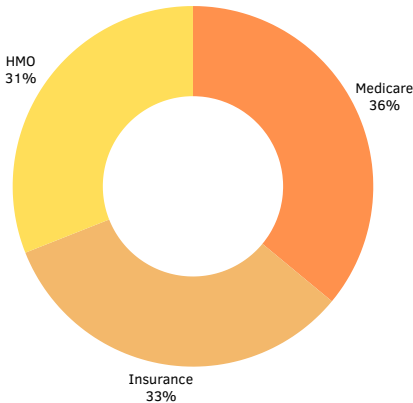


Visits by Discipline

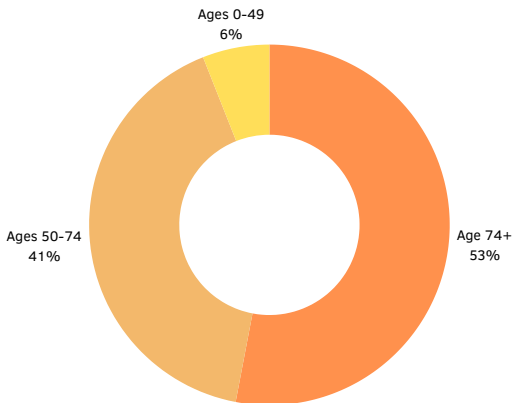


Skilled home health care is designed for individuals who need short-term or ongoing medical care at home, often after a hospital stay, surgery, or for chronic conditions. Services are delivered by licensed professionals such as nurses, physical therapists, occupational therapists, speech therapists, and home health aides. Common skilled services include wound care, IV therapy, medication management, rehabilitation therapies, and patient education to support recovery and safety at home.

Visits by Pay Source

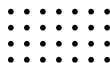


Skilled Patient Age



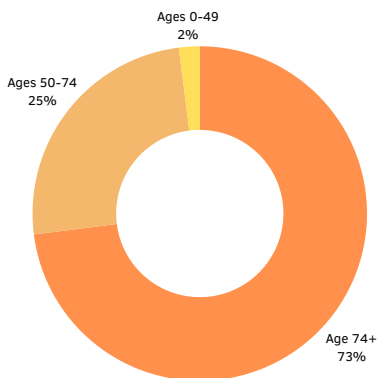

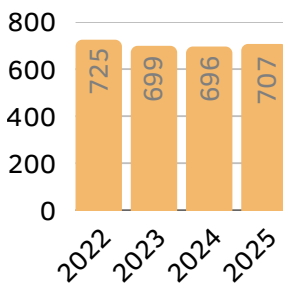

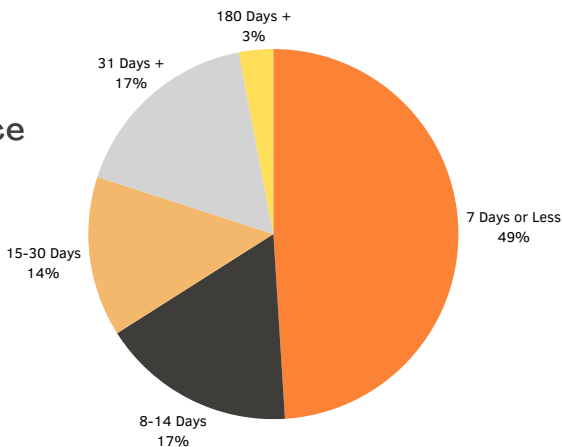
Hospice Patient Age

Length of Service



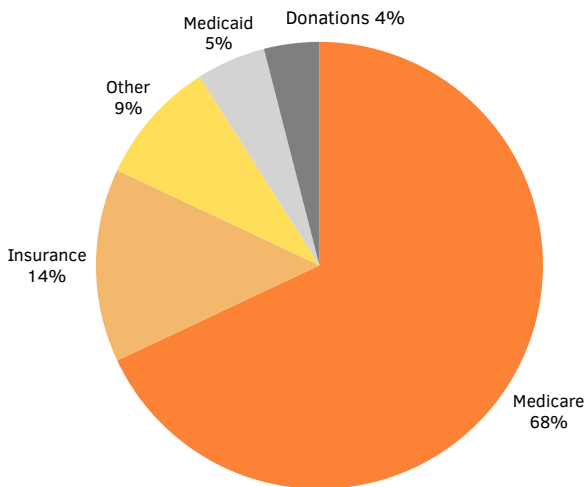
Average Length of Time
